Today i.e On 07/03/2023 at around 11:30 am, a joint team of Kangpokpi District Police, RCs (MPTC), and SDM (Executive Magistrate), Lhungtin Block, Kangpokpi District, numbering about 100 (one hundred) persons led by Shri Th. Thelu Rocky, MPS ASP(LO)/KPI and Insp. B. Lunthang Vaiphei, OC/Saikul-PS under the supervision of Shri Th. Ukramjit Singh, MPS, SP/KPI carried out a mass destruction of illicit poppy plants cultivation in the hills ranges of Sengben Village and Chonyang Village under Lhungtin Sub-Division, Kangpokpi District, Manipur about 27 Km North from Saikul Police Station in which illegal poppy plantation of land covering about 7 (Seven) acres were totally destroyed.

Hence a regular Case under FIR NO. 22(3) 2022 SKL-PS U/S 18(6) NDBPS Act has been registered on Suo-moto case for investigation.
