

INCIDENT REPORT

1. Column of strength 01 Offrs, 01 JCO and 40 Other Ranks of 18 Assam Rifles (Ex Dolaithabi) was launched at 23:15hr on 12 Aug 2023 for domination of T/Gamnomo SoO Camp. The column started induction at 23:15 hrs on 12 Aug 2023 and was effective in location at 02:30hrs on 13 Aug 2023. Column established stops with 4 x small teams to carry out surveillance on routes of ingress and egress from the camp.

2. At approx 04:00hrs small team under Officer at Map Square 5618 observed movement of 2 suspected individuals in the General area. The individuals on being challenged fled from the location. Own column closed in and carried out search of the area. During the search the following items/articles have been seized/recovered by the team of 18th Assam Rifles from General Area.
