




Sir,

I have the honour to report that, on 03/05/2023 at around 08:40 pm some unknown miscreants suspected to be hill tribal community numbering about 1000-1500 persons burnt down my house at Ekou bazar due to Communal violent among the Hill and valley community. In the incident all my household properties including, furnitures, Utensils, Electronic gadgets, Kitchen Wares, Clothes, food and grains etc have been totally gutted.


The list of properties destroyed or loss are mention in the **Annexure (enclosed)**. The Approximate value of destroyed or loss properties is calculated at about Rs. 17,54,000 /- (Seventeen lakhs fifty four thousand).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
