On the 6th May, 2023 at about 8:30. pm an unruly mobs equipped with deadly weapons numbering 200/300 forcibly intruded the office premises of Kangpokpi Police Station and ransacked the office by damaging a good numbers of government properties. Further, they also intruded forcibly into the residential quarter of OC/KPI-PS and opened one steel almirah available inside his private room and scattered all his clothing. The unknown unruly mob also damaged some vehicles which was parked inside this Police Station campus and stole some PS records including case records from the Police Station.

Hence, a Suo-Motu case under FIR No. 22(5)2023 KPI-PS u/s 153(A)/148/149/120(B)/448/427/380 IPC & 3 PDPP ACT-1984 has been registered for investigation.
