Sub: Report.

Sir,

I have the honour to state that today i.e on 10/6/2022 at about 7:30 AM teams of KPI-PS led by SI S. Raju Singh and S.I. Hemjamang Khongsai while conducting intensive frisking and checking near Kalapahar Outpost along NH-2 under the overall instruction of Amrita Sinha, IPS, SP/KPI, ASP(L/O), ASP(Ops) Kangpokpi and under the direct supervision of OC/KPI based on the information of suspicious movement of drug peddlers on NH-2, one Chevrolet Travera, red in colour bearing Regd. No. NL05C-1984 was stopped and during checking by the Police team, the driver was found behaving in a very suspicious manner. The driver of the vehicle was preliminary questioned tactfully at the spot and he eventually admitted that he is a drug peddler transporting illegal drugs along the highway and also further admitted that suspected heroin No. 4 is concealed in the vehicle. The driver of the vehicle was himself identified as one Thaovikhu Mk (21) years S/o Sahriini of Laii Village, Tadubi, Senapati District. He divulged that he obtained the suspected Heroin No. 4 from one Letkfohao Haokip (42) yrs s/o Letkhojang Haokip of T. Champhai Village, Churachandpur. As per the RC book, the involved vehicle was found registered in the name of one KZ Savino S/o Late H Zopianga of H/No. 51, Dr. Haralu colony, Dimapur, Nagaland.

On confirming the presence of drugs in the vehicle no further checking was done in order to observe formalities at the spot. So, immediately Senior Officers of the district namely Shri Tholu Rocky, MPS, ASP(L/O), Md. Abul Kalam, MPS, ASP(Ops) were informed about the matter. 1 (one) Executive Magistrate was also requisitioned to be present in conducting checking of the vehicle and accordingly Shri Salam Bimoljit Singh, MCS of DC Office was deputed by DC Office, Kangpokpi. The vehicle was searched in presence of the above aforesaid senior officers of the district along with independent witnesses and in presence of the Executive Magistrate. Checking of the vehicle was initiated. The detained individual was made to open the cabinet where the suspected Heroin No. 4 was stored. He first removed the wiper of the vehicle using a screwdriver and removed the plastic flap by opening the bonnet of the vehicle. On removing the plastic flap, Plastic soap cases cover in transparent plastic was found neatly stacked in the cavity. The Plastic Soap cases were removed one by one and counted and totalled 71. The plastic soap cases are then placed in 2 (two) transparent Polythene and marked as Lot-1 and Lot-2. Lot 1 contains 35 soap cases marked as 1, 2, 3,..... till 35. Lot 2 contains 36 Soap cases marked as 36, 37, 38.... till 71. The lots marked Lot-1 and Lot-2 were weighed in the presence of the Executive Magistrate and Independent witnesses of KTC (Kangpokpi Town Committee). Lot 1 weighs 1.460 Kgs and Lot-2 weighs 1.495 Kgs, both including the weight of the Plastic Soap cases. The total weight of Lot-1 and Lot-2 totalled 2.955 Kgs.

The approximate value of the suspected Heroin No. 4 is estimated of Rs 21,30,000/- (Twenty one lakhs thirty thousand) only in the local market and 10,65,0000/- (Ten Crores sixty five lakhs) only in the International market.

The recovered 71 soap cases containing suspected Heroin No. 4 and other articles were seized in presence of Executive Magistrate, Independent witnesses and apprehended person at 10:00 am by preparing a formal seizure memo and also obtained their signatures. The accused person was formally arrested at 10.10 AM by observing formalities.

1. 71 Plastic Soap cases containing suspected Heroin No. 4 weighing 2.955 Kgs including the weight of the plastic soap cases.
2. 1 (one) apple I-phone 12 series of JIO Sim with mobile number 9366802076.
3. 1 (one) Aadhar card bearing number 818267647602 in the name of S. Thaovikhu MK s/o Sahriini Laii, Tadubi, Senapati, Manipur 795104.
4. 1 (one) Chevrolet Travera of red colour B/Regn no. NL05C-1984.
5. Certificate of Registration for Chevrolet Travera in the name of KZ Savino of H/No. 51 Dr. Haralu Colony, Dimapur, Nagaland.

Following the order passed by the Hon'ble Spl. Judge, ND&PS, Manipur vide No. SPL-C/ND&PS/2019/659-663 dated 26-11-2019 corresponding Cril. Appeal No. 652 of 2012 (MANU/SC/0073/2016: (2016) 3 SC & 379) the necessary proceedings laid under ND&PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Therefore, the arrested accused person and seized items are handed over to you for taking further necessary legal action please.
