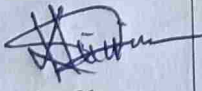

As a result all my valuable property of household were destroyed, looted and burnt down my house along with important documents and vehicles. The approximate value of the lost properties is calculated about Rs 30 Lakhs.

It is therefore request to kindly register a regular case in your good office against the culprits according to the law
