I the undersigned have the honour to state that on 03/05/2023 at around 7:30 pm some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be Kuki Community from different villages entered at Ekou Village, and started damaged my house and house hold properties by burning at Ekou Bazar, Imphal East District, Manipur, PS- Saikul.

The following properties were damaged during the incident:-

- 1. One Kutcha House Rs. 7 lakhs.
- 2. In Cash Rs. 1 Lakhs.
- 3. Gold (2 San)- Rs. 30 thousand.
- 4. Other house hold properties- Rs. 2 lakhs.
- 5. Domestic Animal(2 Ox) and 3(pig)- Rs . 1,60,0000.
- 6. Paddy bags(20 bags) -20 Thousand.

The above damage properties worth about Rs.12,10,000(twelve lakhs and ten thousand)only. I therefore request you to kindly taken up legal action against unknown culprits

I could not report well in time regarding the incident due to I was driving tata truck carrying goods from Jiribam to Imphal for essential needs and suffering a road accident.
