

I the undersigned have the honour to state that on 03/05/2023 at around 7:30 pm some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be Kuki Community from different villages entered at Ekou Village, and started damaged my house and house hold properties by burning at Ekou Bazar, Imphal East District, Manipur, PS- Saikul.

The following properties were damaged during the incident:-


1. One Building Kutcha House - Rs. 20lakhs.
2. In Cash - Rs. 30 thousand.
3. Gold (3 San)- Rs. 45 thousand.
4. Other house hold properties- Rs. 2 lakhs.
5. Domestic Animal(2 Pig)- Rs .40 Thousand.
6. Pan Dukan (including all shops material)- 1.5 Lakhs.
7. Paddy bags(10 bags) -10 Thousand.

The above damage properties worth about 24,75,000. I therefore request you to kindly taken up legal action against unkown culprits

I could not report regarding the incident timely to the concern authority due to misunderstanding and lack of legal knowledge.


