Sub: Report.

Sir.

I have the honour to state that today i.e on 17/6/2022 at about 4:00 PM teams of KPI-PS led by SLS. Raju Singh and S.I. Hemjamang Khongsai while conducting intensive frisking and checking at Kangpokpi P/S Gate along NH-2 under the overall instruction of SP/KPI, ASP(Ops), ASP(L/O), Kangpokpi and under the direct supervision of OC/KPI based on the information of suspicious movement of drug peddlers on NH-2, one Mahindra Bolero, Grey in colour bearing Regd. No. AS12H-1485 was stopped and during checking by the Police team, the driver and the occupant were found behaving in a very suspicious manner. The driver of the vehicle was identified as P. Sahriini Mikrii(56) S/o Puni, Laii, Senapati and the occupant as Paotinmang Khongsai (21) S/o Thanglen Khongsai of J. Songpijang Village, Tengnoupal Sub-Division, Chandel District as per their Aadhar cards. On preliminary enquiries, they denied the presence of contraband drugs in the vehicle. Due to their suspicious nature and on their denial of the transportation of drugs in the vehicle, a mechanic viz. H. Basanta Singh (45) yrs S/o H. Nabachandra of Kangpokpi Ward No. 17 was requisitioned. He inspected the vehicle very carefully and minutely on all sides. He then slid down on the road and checked the undercarriage of the vehicle. On careful examination of the undercarriage of the vehicle, the requisitioned mechanic found irregularities on the vehicle in which two boxes were neatly welded at the under carriage underneath the clutch pedal on the right and underneath the footboard on the left of the Vehicle which is otherwise not found on a normal Bolero vehicle. The accused persons were then interrogated again and they revealed the presence of contraband drugs in the vehicle and that they obtain the drugs from one Mangkholen Touthang (35) yrs S/o Henjangam Touthang (70) yrs of Nungka Village, PS-Saikul, Kangpokpi District, Manipur.

On confirming the presence of drugs in the vehicle no further checking was done in order to observe formalities at the spot. So, immediately Senior Officers of the district ASP(Ops) and ASP(L/O) were informed about the details of the matter. I (one) Executive Magistrate was also requisitioned to be present in conducting checking of the vehicle. As per requisition, one executive magistrate namely Smt Sithonliu Pamai, MCS, SDC and Branch Officer, DC office Kangpokpi was deputed by DC, Kangpokpi at the PO. Due to intense rain and obstruction of the flow of normal traffic, the vehicle was driven up to Kangpokpi P/S with permission of the Executive Magistrate. The vehicle was searched in the presence of the above aforesaid senior officers of the district along with independent witnesses and in the presence of the Executive Magistrate. The accused persons were made to open the cavity where the suspected contraband drug was stored.

They slid off the padding of the insulated floor which revealed a cavity fastened with screws. Owing to the tightness of corners, P. Sahriini Mikrii(56) undid the screws and brought out a black plastic bags. On counting, it yielded 4 (four) transparent Polythene bags suspected to be brown sugar. The 4(four) transparent Polythene bags suspected to contain Brown sugar were marked 1,2,3 till 4. It was then distributed into 2 (two) lots, Lot-1 and Lot-2 containing 2(two) Plastic Polythene bags of suspected Brown Sugar each. Weighing was done in the presence of the Executive magistrate and Independent witnesses by preparing a formal weighing memo. On weighing, Lot-1 weighs 1.015 Kgs and Lot-2 weighs 1.010 Kgs. The combined weight of Lot-1 and Lot-2 was then weighed and it weighs 2.025 Kgs (including the weight of the transparent polythene bags).

The approximate value of the suspected Brown Sugar is estimated to be Rs.34,13,200/- (Thirty four lakhs thirteen thousand two hundred) only in the local market and Rs. 34,13,20,000/- (Thirty four crores and thirteen lakhs twenty thousand) only in the International market.

The recovered 2.025 Kgs of suspected Brown Sugar and other articles were seized in presence of Executive Magistrate, Independent witnesses at 5:30 Pm by preparing a formal seizure memo and also obtained their signatures. The accused person was formally arrested at 5:40 PM by observing formalities.

- 3. 1(one) Aadhar card in the name of P. Sahriini Mikrii S/o Puni, Laii, Senapati.
- 4. 1(one) Aadhar card in the name of Paotinmang Khongsai S/o Thanglen Khongsai.
- 5. 2(two) Mobile Phones (Vivo Touch screen with Mobile No. 9366561743 of Airtel and Samsung Key pad Mobile Phone with Mobile No. 8413079224)

Following the order passed by the Hon'ble Spl. Judge, ND&PS, Manipur vide No. SPL-C/ND&PS/2019/659-663 dated 26-11-2019 corresponding Cril. Appeal No. 652 of 2012 (MANU/SC/0073/2016: (2016) 3 SC & 379) the necessary proceedings laid under ND&PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Therefore, the arrested accused persons and seized items are handed over to you for taking further necessary legal

action please.
