

I have the honour to report that, on 03/05/2023 at around 9:30 pm some unknown miscreants suspected to be hill tribal community numbering about 1500 persons entered our village, Ekou Bazar, PO- Saikul, PS- Saikul, Imphal East District about 5 Km south from Saikul-PS . and They vandalised my house and looted all the moveable and vaulable properties and burnt down all the remaining into ashes leaving us homeless. Fearing lost of live me and my family left our home and as of now we temporarily stayed at Gangpijang Village, Saikul Sub Division Kangpokpi District, Manipur. The list of properties destroyed or loss are mentioned in the **Annexure (enclosed)**.

The approximate value of the lost properties is calculated at about Rs.32.80,000( Thirty two lakhs and eighty thousand)only

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
