Sir,

I have the honour to state that, on 28-05-2023 at around 02:10 Pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol, World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC), numbering about 100-200 persons carrying sophisticated weapons like AK, SLR, INSAS rifles and .303 rifles forcefully attacked our village, Khokon village, under Saikul Sub-Division, Kangpokpi District, Manipur about 9 Km South from Saikul-PS. As a result the village volunteers retaliate against the Meitei community in order to safeguard our village and there was a firing going on between the two party. Fearing loss of lives we had left our house and fled to the jungle escaped to Saikul Bazar and as of now we temporarily stayed at Twinomjang Relief Camp, Saikul under Kangpokpi District. In the incident my house alongwith some valuable household properties was damaged by stray bullets.

The list of properties destroyed or loss are mentioned in the **Annexure(enclosed**). The Approximate value of lost properties is calculated at about Rs. 5,00,000/- (five lakhs).

Due to lack of legal knowledge I could not report in time.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
