

Subject : Report for FIR on Looted/ Vandalized / Burnt house/ Properties.

Sir,

- With reference to the above cited subject, I have the honour to report to you as below :-
1. That, I, Manglenthang Guite age 45 h/o Lhingneilam Guite belong to a Kuki Community, a Schedule Tribe recognized under the constitution of India. By virtue of which I am entitled for protection under SC/ST (Prevention of Atrocities) Act, 1989. Whereby, I am a permanent resident of Wakonphai Village. PO&PS Saikul, Kangpokpi District.
  2. That, On 20<sup>th</sup> May, 2023 at 11 am, a huge contingent of armed Radical Meitei/ Meitei Mobs Arambai Tenggol and Meitei Leepun along with State Forces like Manipur Police Commandos and Indian Reserve Battalion (IRB) attack our village, and in the process looted/ vandalized/ burnt our house and properties.
  3. That, the above said Criminal with their inhumane activities have caused me grave mental agony. Not withstanding the fact that, their unruly activities have me loss enormous wealth estimated to be Rs. 18 Lakhs only.
  4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us.

Henceforth, we are taking refuge at Ebenezer Relief Centre, Churachandpur District.  
I, therefore, request you to register on FIR/ZERO FIR and bring justice
