That, On 20th May, 2023 at 11 am, a huge contingent of armed Radical Meitei/ Meitei Mobs Arambai Tenggol and Meitei Leepun along with State Forces like Manipur Police Commandos and Indian Reserve Battalion (IRB) attack our village, and in the process looted/ vandalized/ burnt our house and 2.
