Sir,

As understood, on 08/11/2022 at about 1:30 pm, self and police party went to Lungtein Village for making an enquiry regarding gunshot at Lungtein Village area on 07/11/2022 at about 7:30 pm. On enquiry, it is learnt that one individual namely, Sei Goudal @ Hezoe @ Kumbem (38) yrs of Lamang Chongloi of Kangpokpi word no. 8, Kangpokpi District, Camp Co of KRA (CoO) T. Gawnson Camp at Lungtein Village, went to visit some workers engaged in ground levelling using JCB at K-Hangshing Memorial Tomb Stone Complex at Lungtein Village. After completing ground levelling, the workers left the place along with JCB and he was the only person staying behind. While standing on the gallery, he took out his pistol and fired 5 (five) rounds towards the raddy field located on the Southern side of the road to check whether his pistol was in working condition. Later, he informed one Steward, Co KLA/KLO about the gunshot and also called one Andrew of KLA CW but could not reach him.

I therefore, request you to take up necessary action according to law.
