Sir,

We the undersigned have the honour to state that on 03/05/2023 at around 7:30 pm some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be Kuki Community from different villages entered at our Ekou Village, and attacked to the villager by opening fire and started vandalised all the houses and household properties and burnt down into ash. In that, all the villager fled from our village to save their live. Later on i.e. 25<sup>th</sup> August, 2023 at about 5:00 pm received a reliable information that the above mentioned unknown culprits vandalised / destroyed and looted the following properties of our village (Ekou) on 15/05/2023.

1. Ereima Tample = Rs. 40,00,000-/-
2. Community Hall = Rs.20,00,000-/-
3. Office Building of Ekou Youth Club = Rs.30,00,000-/-
4. Office Building of Ekou Women welfear Association (Meira Paibi) =Rs.15,00,000-/-
5. Ekou Upper Primary School = Rs. 25,00,000-/-
6. Makeng Dolaithabi Panchayat Ghar, Ekou =Rs. 10,00,000-/-
7. 3 (Three) Public Toilet = Rs. 6,00,000-/-
