

Subject: - Report.

Sir,

I the under signed have the honour to state that I am the residence of Pukhao Terapur and staying at Saikul bazar in a rented house of Mr. Boihen and opening/running a mobile phone shop (Mas Mobile repairing shop) at Saikul bazar. On 03/05/2023 at about 7:00 pm, while I along with my mother and my son of 6 years old living inside our rented house we received a reliable information that the surrounding Kuki community would attacked on Meitei community who were staying at Saikul bazar. However, we somehow managed to escape from Saikul bazar and took shelter at Heingang Makha Leikai community Hall Relief Camp. Imphal East, Manipur. On 5/5/2023 morning at about 9.00am while staying at relief camp received an information that on the day of incident i.e 03/5/2023 at 8.00 pm all the items of my Mobile phone shop and household properties were looted by the Kuki peoples of surrounding village after breaking the doors.

The following properties of belonging to me were damaged in the incident.

1. Smart Phone handset numbering about 200 approximately Rs. 400000/-
2. Mobile repairing accessory Rs. 50,000/- (Fifty thousand) only.
3. One LG computer set Rs. 40,000/- (forty thousand) only
4. Ubon Bluetoot speakers 10 Nos. head phone 30, USB cable 50, Pen drive 50, HP printer 1(Rs. 50,000 only.

The above damaged properties worth about Rs. 5,40,000/- (Five lakh Forty thousand)only.

I therefore request to kindly taken up legal action against the Kuki people of surrounding village.

I could not report well in time due to Sick as Asthma Bronchitis and lack of legal knowledge.
