Today i.e 5<sup>th</sup> July, 2022 at @ 9:05 Pm, received a reliable information that on the same day at 9.00 PM one Maruti Suzuki Van without registration number driven by an unknown driver coming from Senapati and proceeding towards Imphal with two occupants and one Chevrolet Car bearing registration number MN 01G 7254 driven by an unknown driver coming from Imphal and proceeding towards Senapati with one occupant met a head on collision near Daili village on NH-2 due to rash and negligent driving on the part of both the unknown drivers as a result of which 3(three) occupants of the above Maruti Suzuki Van and 2(two) occupants of the Chevrolet Car met serious injuries on their persons. The injured persons from the Maruti Suzuki Van were evacuated to District Hospital, Kangpokpi and the injured persons from the Chevrolet car evacuated to Mission Hospital, Kangpokpi. However, the driver of the Maruti Suzuki Van succumbed to his injuries at District Hospital, Kangpokpi.

Hence, a suo-motu case under FIR No. 24(7)2022 KPI-PS u/s 279/338/427/304-A IPC has been registered for investigation.
