With humble request, I undersigned applicant, who is the authorized signatory of Bhartia Infra Projects Ltd. Beg to request you the following few words for favour of your kind consideration and necessary action.

That on 09.05.2023 at about 4:30 PM, a group of unknown miscreants numbering about 25 have overpowered the workers of BIPL at quarry located at Bungmol village, by holding deadly weapons such as small arms, axes, Dao, Big Knife, Barrel etc. and assaulted the workers and burnt down our machineries.

In the past also they have been seen frequently visiting the area and making disturbances to the work of BIPL.

It is therefore requesting your good self may kindly cause the arrest of the said 25 miscreants who burned the machineries as early as possible and booked according to law, so as to enable peace and tranquility at the said area.
