Sir,

I have the honour to report that, today on 03/5/2023 at around 8:40pm some unknown miscreants suspected to be hill tribal community numbering about 1000-1500 persons burnt down Exou village due to communal violent among the Hill and Valley Community. In that incident both my houses were included and all the household properties including, jewellery, furnitures, utensil, electronic gadgets, kitchen wares, clothes, foods and grains etc have been totally gutted.

The approximate value of the lost properties is calculated at about Rs. 3 to 4 Crores.

It is therefore, requested to booked the culprits and take necessary legal action according to law.
