Sub: Report.

Sir,

I have the honour to state that today i.e on 19/7/2022 at about 5:30 pm a selected teams of KPI-PS led byOC/KPI-PS assisted by SI Hemjamang Khongsai, SI Sehtinsei Khongsai and ASI Thangkhopau Gangte (self) and Police teams along with WPC while conducting intensive frisking and checking near T. Khullenalong NH-2under the overall instruction of Amrita Sinha, IPS, SP/KPI and DSP(GSPM) based on the information of suspicious movement of drug peddlers on NH-2, one Diesel Auto-Rickshaw was stopped at near T. Khullen village and during checking by the Police team, two women occupants/passengersinside the vehicle were seen nervous and behaving in a very suspicious manner. Onthorough checking of the saidvehicle, found two suspected black polythene bags in the vehicle. On preliminary questioning, the two women passengers admittedthemselves as the owner and they also disclosed that the suspected polythene bags were containing contraband drugs which they have transported without the knowledge of the driver. The two women occupants/passengers were identified as (i) Lhaichong Singsit (55) yrs W/o (L) Hekhup Singsit of Kangpokpi Ward No. 8, PS-Kangpokpi, District-Kangpokpi, Manipur and (ii) Tingneichong Kipgen (55) yrs W/o (L) Seiboi Kipgen of Tujang part-1, PS-Kangpokpi, District-Kangpokpi, Manipur.On further questioning, they disclosed thatthey have transported the said drug forhanding over at Senapati to oneLucksonwho was waiting them. Immediately police teams led by OC/KPI-PS have taken one apprehended women drug peddlers at Karong Bazar while another police team look after the detained vehicle and the recovered drugs with the other apprehended women passenger by informing senior officers (DSP/GSPM). The raiding team successfully apprehended the co-drug peddler who was waiting for the consignment at Karong Bazar. The apprehended person was identified as Luckson Raomai (34) yrs S/o R. Biren of Khamson village, PS- Senapati, Dist-Senapati, Manipur. On preliminary verification, he disclosed himself waiting the recovered drug from the two apprehended persons.

The apprehended persons involved in the chain of smuggling of drugs were taken at the place of occurrence i.e near T. Khullen village. At the spot, one gazetted office namely Shri L. Sheimang Khongsai, MPS, DSP(GSPM) and two independent witnesses who were earlier informed are present to stand for witnesses of seizure and arrest. However, due to vulnerability of the situation and inconveniences caused by incessant rain and darkness, necessary formalities cannot be performed at the spot and with the permission of gazetted officer, the apprehended persons along with the recovered drug and independent witnesses were taken to KPI-PS for conducting further necessary legal formalities.

On arrival at KPI-PS, in presence of gazetted officer and independent witnesses, the suspected black polythene bags were opened and found two transparent polythene bags containing suspected Brown Sugar. The recovered two polythene bags were marked Lot-1 and Lot-2 for identification. On weighing the Lots i.e Lot-1 weighs 0.520 grams and Lot-2 weighs 1.015 kgs including the weight of the plastic packages. The total weight was 1.535 kgs.

The recovered item suspected to be Brown sugar and other articles were seized in presence of gazetted police officer and independent witnesses and apprehended persons by preparing a formal seizure memo and also obtained their signatures at 8:40 pm. The three

apprehended persons were also arrested at 8:50 pm in presence of independent witnesses by preparing a formal arrest-memo.

Particulars of seized articles

1. Two transparent polythene bags containing suspected to be Brown Sugar weighing 1.535 Kgs including the weight of the transparent polythene.

2. Three mobile phones handsets-(i) Realme Note-9 with Jiosimcard no. 8837336801, (ii) Redmi 91 with Airtel simcard bearing no. 9612411310 and (iii) Nokia Keypad Phone black in colur with Airtel Sim Card bearing No. 8413036470.

3. One Honda Venue car (white colour)bearing registration no. NL-07-CA-5921. And the approximate value is estimated of Rs 38,00,000/- (Thirty-eight lakhs) only in the local market and 38,00,00,000/- (Thirty-eight crores) only in the International market.

Following the order passed by the Hon'ble Spl. Judge, ND&PS, Manipur vide No. SPL-C/ND&PS/2019/659-663 dated 26-11-2019 corresponding Cril. Appeal No. 652 of 2012 (MANU/SC/0073/2016: (2016) 3 SC & 379) the necessary proceedings laid under ND&PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Therefore, the arrested three accused persons and seized items are handed over to you for taking further necessary legal action please.

This report is treated as an O.E of FIR No. 25(7)2022 KPI-PS u/s 21(c)/29/60(3)ND & PS Act Yours faithfully
