Subject: Submission of Enquiry Report.

Sir,

I have the honour to state that with reference to GD No.24/2022/KPI-PS dated 26/7/2022 regarding receipt of information about assault incident at Kalapahar Bazar on the same day at about 9:00 PM where one Kh. Noren (39) S/o (L) Kh. Thoibi of Isheikha village PO & PS-Sagolmang presently posted at Kalapahar Outpost 4th IRB was assaulted by unknown persons thereby receiving injuries on his person, I have visited the place of occurrence immediately and enquired the matter discreetly. The exact location is at near the intersection point of the approach road toward Upper Kalapahar, a few meters away from NH-02.

On further enquiry, one witness namely O. Subhash (39) S/o (L) O. Manao of Yairipok Keisham Leikai, PO & PS-Yairipok stated that on the same day at around 8:30 pm he accompanied Kh.Noren to Kalapahar Bazar to purchase some grocery items. They were travelling in a car owned by Kh. Noren and while proceeding back to Kalapahar Outpost from Upper Kalapahar road side there was traffic jam and many loaded trucks proceeding towards Imphal side were blocking the road. Kh. Noren alighted from the vehicle and managed the trucks which later started moving. As the vehicles started moving, a white colour Bolero coming from Kangpokpi side took a right turn to proceed towards upper Kalapahar side. The driver of the white colour Bolero told them why their vehicle was not parked in proper order and asked where they are from in a demeaning way and started beating him and fled away, as a result of which the aforesaid person received injuries on his person and evacuated to Kangpokpi District Hospital for medical treatment.

Therefore, the enquiry report is hereby submitted for favour of kind perusal and further necessary action.
