With due respect and regards, I would like to lay down few lines before you for kind knowledge and necessary action: That, on the night of 3rd May 2023, while I was at my relatives house, at around 10 00 pm, some unknown miscreants have burnt down my house located at Thangal Bazar, Ekou House No 08 POBPS - Saikul, Kangpokpi District, As a result, the inferno have left my house into ashes thereby losing all my properties - all furnitures, all garments and clothing, electronic items, kitchen utensil important documents of educational certificates and others. The estimated value of properties lost is estimated to be around Rs 15,00,000 (Fifteen Lakhs).

I could not report the incident timely due to the prevailing law and order situation in the state.

Therefore, I request your good office to kindly take up necessary action in this regard.
