I have the honour to report that, on 04/05/2023 at around 5:30 am, the large number of kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, Came to my house and destroyed my house located at lower Kalapahar and one of my Shop (hotel, Fish Centre cum Vegetable shop) located at Lower Kalapahar bazar also destroyed by the rioters and looted much of my properties.

The properties that were looted are as follows:

- i. 2 Bed -Rs. 20,000/-
- ii. 1 Almirah- Rs. 25,000/-
- iii. 4 Table -Rs. 10,000/-
- iv. 1 Television- Rs. 7000/-
- v. 3 Gas Cylinder with Burner, Kitchen items- Rs. 30,000/-
- vi. Cash - Rs. 21,000/-
- vii. Cloths- Rs. 40,000/-
- viii. 2 Refrigerator & 1 Selling Fan & 1 stand Fan -Rs. 36,000/-
- ix. 2 Fish Box & other fish item- Rs. 25,000/-
- x. Vegetable materials and other items- Rs. 64,000/-
- xi. House Materials - Rs. 30000/-

Resulting which my house and hotel was totally destroyed. The approximate value of my house and hotel, and house hold materials is about Rs. 2,99,000/- (Rupees Two lakh Ninety nine thousand only). Regarding the matters I couldn't able to report to the concern PS i.e Kangpokpi PS till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
