The properties that were looted are as follows:

- ii. 1 Almirah- Rs. 25,000/-
- iii. 4 Table -Rs. 10,000/-
- iv. 1 Television- Rs. 7000/-
- v. 3 Gas Cylinder with Burner, Kitchen items- Rs. 30,000/-
- vi. Cash Rs. 21,000/-
- Cloths- Rs. 40,000/-VII.
- viil. 2 Refrigerator & 1 Selling Fan & 1 stand Fan -Rs. 36,000/-
- ix. 2 Fish Box & other fish item- Rs. 25,000/-
- x. Vegetable materials and other items- Rs. 64,000/-
- xl. House Materials Rs. 30000/-

Resulting which my house and hotel was totally destroyed. The approximate value of my house and hotel, and house hold materials is about Rs. 2,99,000/-(Rupees Two lakh Ninety nine thousand only). Regarding the matters I couldn't able to report to the concern PS i.e Kangpokpi PS till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
