I have the honour to report that, on 03/05/2023 at around 8:00 pm, the large number of Kukis rioters by holding deadly weapon came to my house and destroyed my house and household properties located at Kangpokpi ward-I and looted much of my properties.

The Properties that were destructed and looted are as follows:-

- i) House (pucca building) Rs. 35,00,000/-
- ii) Cloths - Rs. 1,85,000/-
- iii) Gas stove (2 nos.) - Rs. 6,000/-
- iv) Gas cylinder (6 nos) - Rs. 7,500/-
- v) Almira, Chair, table, sofa set etc - Rs. 6,50,000/-
- vi) Solar Plate, Battery, Inverter - Rs. 35,000/-
- vii) Gold ornaments - Rs. 2,04,000/-
- viii) TV, Refrigerator, Washing machine - Rs. 1,62,000/-
- ix) Oven, Mixer Grinder - Rs. 1,55,000/-
- x) Laptop, Printer - Rs 68,000/-
- xi) Utensil Rs. 1,50,000/-

Total approximate value is about Rs. 49,83,000/- approximately.

Regarding the matter I couldn't able to report to the concern PS i.e Kangpokpi PS till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to Kindly look into the matter and take up necessary action at the earliest.
