Today i.e. 11/09/2022 at 8:05 pm, received a reliable information that on the same day at about 7:40 pm, two loaded trucks bearing registration Nos. MN04-6337 and MN02B-1013 coming from Dimapur and proceeding towards Imphal was parked on NH-2 near Changoubung village for repairing tyres of MN04-6337 at which the Tata truck B/R No. MN04-6337 was hit at the back by one loaded truck B/R No. NL01AA 9329 driven by one unknown driver coming from the same direction as a result of which both the drivers of the parked two Tata Trucks namely Ahongsangbam Robartson Singh (22) s/o A. Ithen Singh and Ahongsangbam Eken Singh (52) s/o A. Bihari singh of Ngangkhal Lawai, Bishnupur District got serious injuries on their persons. The injured persons were immediately evacuated to District Hospital, Kangpokpi by the Highway Patrol Team of Kangpokpi Police Station for medical treatment. However, they were referred to Imphal by the concerned doctor for further medical treatment. The injured driver Mr. Ahongsangbam Robartson Singh (22) s/o A. Ithen Singh of Ngangkha Lawai, Bishnupur who is the driver of the tata truck B/R No. MN02B-1013 succumbed to his injuries on the way to hospital and the other driver Ahongsangbam Eken Singh (52) s/o A. Bihari singh of Ngangkhal Lawai, Bishnupur District is admitted to the Hospital with grievous injury on his person. The vehicle B/R No. NL01AA-9329 also got damaged all due to rash and negligent driving on the part of the unknown driver bearing registration No. NL01AA-9329.

Hence, a Suo-Motu case under FIR No. 29(9) 2022 KPI-PS u/s 279/338/427/304-A IPC is registered for investigation.
