Sir,

Today i.e On 16/1/2023 at around 11:50 am, a joint team of Kangpokpi District police, NAB, MR/IRB and Forest Department, Kangpokpi, SDO Lhungfin block, Kangpokpi District, numbering about 70 (seventy) persons led by Shri. Th. Nirsamjit Singh MPS, SP/KPI carried out a mass destruction of illicit Poppy plants cultivation at the hill ranges of Mongjang village under Lhungfin Sub-Division, Kangpokpi District, Manipur about 34 Kms East from the Saikul Police station in which illegal Poppy plantation of land covering about 22 (twentytwo) acres were totally destroyed.
