Today 12.07.23/12/2022 at around 11:35 am. a joint team of Kangpokpi District Police, NAB, Forest Department, Kangpokpi, Sub-Inspector Clock, Kangpokpi District and 22 Assam Rifles, Saker post numbering about 70 (seventy) persons led by Shri L. Shermaung Khongai mps, DCP G. C. S. m/pki under the supervision of Smt. ~~Armita~~ Cingha IAS, G. C. S. m/pki carried out a mass destruction of illicit poppy plants cultivation in the hill range of Motkwa Village and Puleizang Village under Shungthin Sub-Division, Kangpokpi District, Manipur about 25 kms north from the Saikul Police Station in which illegal poppy plantation of land covering about 10 (ten) acres. were destroyed.

Hence, a regular case under F.I.R. No. 30(12) 2022 u/s 18(b) ND & PS Act. has been registered for investigation.
