I am to report that on 4<sup>th</sup> May 2023 at around 9:30 a.m. a huge Kuki mob armed with deadly weapons like sticks, iron rods, daos, catapults, inflammable materials etc. burnt by residential house which is situated along the Cattle Farm Road, Near Shiva Mandir – Lower Toribari, Dallil Village, Kangpokpi Dist. Manipur. The loss is worth more than 39 (Thirty-nine) Lakhs.

The incident could not be reported timely due to the prevailing situation and safety reasons.

It is therefore, requested to kindly take necessary action at the earliest.

Details about my family members and properties ruined, not recovered are attached.
