Sub - Report

Sir,

I have the honour to state, On 28-05-2023 at around 6:30 pm some unknown miscreants suspected to be a member of Meitei Youth League, Kangleipak Kamba Lup (KKL) Arambai Tenggol, Aolod Meitei Council (WMC) Schedule Tribe Demand Committee (STDC) and women wings, numbering about 1500 - 2000 persons carrying sophisticated weapons like AK, SLR, INSAS and 303 Rifles forcefully entered our villages, Twichin villages having 57 houses under Saikul - Sub - Division, Kangpokpi District Manipur about 30 km South East from Saikul - PS after looting all our house properties including Domestic animals and Cattle, they vandalised and burnt down all our house including Church and Church properties Church Office, Twichin primary School, Anganwadi Centre, Community Hall, Granaries and all the household properties to the ground leaving all of us homeless. The approximate value of properties destroyed is calculated at about Rs 70,00,00,000 (Seventy Crores).

It is therefore requested you to kindly register a regular case and take necessary legal action against the Culprits according to law.
