Sir,

1. On 15<sup>th</sup> September, 2022 at around 2145 hrs based on specific input received from own sources regarding extortion from loaded vehicles plying along NH-2 in the general area of Daili Village, a team of 'C' Coy (COB Kangpokpi) of 22 Assam Rifles immediately launched an operation and during which one individual was found stopping one Dimapur bound DI Tata bearing Rgd. No. AS-01NC-3392 carrying fishes in a very suspicious manner at Daili Village near waiting shed and he was overpowered/apprehended at the spot. On being search of his body, (a) one Vivo mobile phone and (b) cash amounting Rs 11,840/-(Eleven Thousand Eight hundred and forty) were found from his possession. The apprehended individual was identified as ManggoulalChongloi (26) yrs S/o LutkhoseiChongloi of Kangpokpi Town Ward No. 7. He is highly suspected to be having nexus with UG outfits operating in Kangpokpi Town areas.
2. The above apprehended person has been handed over to you at 2400 hrs on 16<sup>th</sup> September 2022 for further necessary action.
