Sir,
I have the honour to state that on 28-5-2023 at around 2:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisation, Meitei Leipon, Kangleipah Kamba Lup (KKL) Arambai Tenggol Alorid Meitei Council (WMC) Schedule Tribe Demand Committee (STDC) numbering about 100 - 200 persons carrying sophisticated weapon like AK, SLR, INSAS rifles and 303 Rifles forcefully entered our village, T. Wakonphai village, having 32 houses under Saikul - Sub-Division, Kangpokpi District, Manipur about 9km South from Saikul - PS. after looting and vandalising they burnt down around 10 houses including teacher Quarter and all the household properties to the ground leaving them homeless. Some practical instrument which were kept at Teachers Quarter issued by Inside North east, NGO for Educational practices in Electric and Mechanical engineering were also gutted. The approximate value of destroyed properties is calculated at about Rs 1,00,00,000 / (One Crore).

It is therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to laws.
