Sub-Report

Sir,

I have the honour to state that on 28-6-2023 at around 2:00 pm some unknown miscreants suspected to be members of Meitei Youth Organisation, Meitei Leepun, Kangleipah Kamba Lup (KKL) Brambai Tenggal, Global Meitei Council (WMC) Schedule Tribe Demand Committee (STDL) numbering about 100-200 person carrying sophisticated weapon like AK, SLR, INSAS Rifles and 303 Rifles forcefully entered our village H. Molhoi village having 10 houses, under Saikul Sub-Division, Kangpokpi District Manipur about 10km South from Saikul-PS after looting all the moveable properties they vandalised and burnt down all our house including Church and Church properties, Church Office, Granaries and all the household properties to the ground leaving all of us homeless. The approximate value of destroyed properties is calculated at about Rs 10,00,00,000 (Ten Crores).

It is therefore, requested you to kindly register a regular case and take necessary legal action against the culprit according to law.
