Sir,

I have the honour to state that on 28-05-2023 at around 6:00pm some unknown miscreants suspected to be a members of Meitei Youth Organisation, Meitei Leepun, Kangleipak Kanba Lup (KKL), Brambai Tenggal and World Meitei Council (WMC) Schedule Tribe Demand Commi Tee (STDC) numbering about 1000 persons, carrying sophisticated weapon like AK, SLR, INSAS and 303 Rifles forcefully entered our village, Molnomphai village having 11 houses under Saikul Sub-Division, Kangpokpi District Manipur having 11 houses about 20 km East from Saikul-PS. They burnt down all our houses including church, Church properties Gramaries including one two wheelers, to the ground leaving all of us homeless. The approximate value of lost property is calculated at about Rs 15,00,00,000 (fifteen Crores).

It is therefore requested to kindly register a regular case without delay and booked the culprits and take necessary legal action against them according to law.
