Subject: Complaint for lodging of FIR against the Kuki
armed group for looting of house - cum - shop.

Sir,

Most respectfully, I beg to state that a large numbers of Kuki Civilians group backed by many armed militant suddenly attacked my house - cum - shop located at Saikul Bazar in the Night of 3rd May, 2023 and looted all belonging in the shop including vehicle, gold, money worth Rs 30,00,000 (Rupees thirty lakh) only. Our family rush ed to the Saikul Police Station and halted there for a night. In the next day we shifted to other place with the help of Assam Rifles and Manipur Police and reached the Relief Camp, Pangli Yangdong on 4/5/23 we lost all our properties and we don't have any chance to set up our business.

I, on behalf of our family, request you to kindly take up necessary action against the warring Kuki Community and Kuki armed militants by lodging FIR at an early date.
