Sir,

With due respect, I have the honour to state a large number of Kuki Community backed by large numbers of Kuki armed militant attacked my house and burnt down our house. They looted all properties worth Rs 10,00,000 (Rupees ten lakhs) only. We don't have any chance to return to our village, Ekou, Imphal East District due to warring group of Kukis are inhabiting all around my village. Our family have been taking shelter at Pangei Yangdong Relief camp since 4/06/2023.

I, therefore, request you to kindly take necessary action against the Kuki Community and their armed militants by lodging FIR at the earliest.
