Sub: Complaint for lodging FIR against the Kuki Community and
Kuki armed group for burnt down and looting of house.

Sir,

Most respectfully, I beg to state that a large number of Kukis
Community backed by many armed personnel attacked our house, and
burnt down our houses located at Molkon Bazar on the night of 3rd
May 2023. They threatened to kill our family. They looted all our properties
including vehicles, money and gold ornaments about Rs 15 Lakhs (Rupees fifteen
lakh). To save our lives we left our residence, Molkon Village, Khundrah
pham Assembly Constituency and took shelter at the Relief Camp opened
at Pangei Yangdong from 4/05/2023. We don't have any chance to return
to our original residence, Molkon as wild Kukis are inhabiting all around
our village.

I, on behalf of our family, request you to kindly take
necessary action against the Kuki Community and their supporter Kuki
armed militants by lodging a FIR at an early date.
