Subject: - Report.

Sir,

I have the honour to report that on 19/11/2022 at about 3:00 pm my daughter namely Saraswati Ramudamu @ Ankita (23) and her 2 (two) children namely Master Puran (4 Yrs.) s/o Deven Lohar of Kanglatongbi, AR Colony, Imphal West and baby Rupmani (2 months) d/o Deven Lohar of Kanglatongbi, AR Colony, Imphal West were found dead at my rented residence at Parsain Village. The two children were found on the 1<sup>st</sup> Storey of our Cowshed cum kitchen which was used to store straws and my daughter found hanging one hundred metres away in the Jungle.

My daughter was found missing on the 17/11/2022 which I came to know at around 7.00 PM of 17/11/2022. Deven Lohar (husband of my daughter) has lodged a missing report with the Officer-In-charge of Sekmai Police Station on 18/11/2022 at around 6.10 PM. My daughter had left a Suicide note at her In-laws residence and it was found on the 17/11/2022 at around 7.30 PM and he did not take the suicide note along with him when he went to lodge the missing report. Further, after Post mortem examination, when the dead body of my daughter and her children were brought from RIMS Morgue, the villagers agitated stating that the family should bring out the suicide note and make the public aware of its contents. It was only then that the suicide note was made public by the family which is highly suspicious in nature.

As per the suicide note, my daughter has faced severe trauma at her In-laws house facing abuse and torture by the families and this may have led her to the extreme step where she was found dead by hanging along with her 2(two) children. My daughter Saraswati Ramudamu @ Ankita) could not bear the pangs of torture by her mother-in-law as her husband is also always with his mother's side.

I therefore request you to kindly initiate necessary legal action against them. The Suicide note is hereby enclosed herewith for reference.
