Sir,

With due respect, I have the honour to report the following few lines that, I along with my family members were staying at one rented house owned by one Hepuni of Daily village Kangpokpi district since last 10 years back. However, on 3rd May, 2023 at around 6:30 pm, some unknown armed miscreants suspected to be Kuki militants burned down/torch many houses and looted many valuable properties of Meitei houses at daily village Kangpokpi district. In that, the unknown arms miscreant looted my household properties like furniture items, kitchen items, utensil items, clothing, electronics items from the above mention rented house. The approximate value of looted properties are estimated at Rs. 7,00,000/- (Seven lakh) only approximately.

The incident could not be reported immediately due to insecurity of our live and volatile situation of the area.

It is, therefore, requested you to kindly take up necessary legal action against the miscreants involved in the commission of the crime.
