I have the honour to report that I have received a reliable information that on the 7th December, 2022 at about 10.00 PM a cadre of KRA viz; S/s Lt. Albert @ Hegou Khongsai(40) S/o Palet Khongsai of Gallam Village presently residing at Kangpokpi Ward No. 15 (Phungtin Veng) and 2 (two) civilians viz; Ngamkhohao Kipgen @ Boipu (28) S/o (L) Lalthang Kipgen of Joujang Village, Saparmeina, presently residing at Ward No. 15 Kangpokpi and Shri Paominlal (47) @ Lalboi Dimngel of Kangpokpi Ward No. 10 had a Kangpokpi and Shri Paominlal (47) @ Lalboi Dimngel of Kangpokpi Ward No. 10 had a drinking session at Kangpokpi Mission cemetery. During the drinking session, one of the civilians took a Pistol which was in the possession of Albert @Hegou Khongsai and reportedly fired a round causing serious injury on Albert Khongsai. He was immediately evacuated to Raj Medicity, Imphal for Medical treatment.

This report is treated as an O.E of the case FIR No. 40(12)2022 KPI-PS u/s 307/326/34 IPC & 25(1-C) A. Act.
