Subject: Report

Sir,

With due respect and regard, I have the honour to report that today i.e. 18/01/2022 at around 7:00 pm based on a specific input about the loitering of some unknown UG group intend to extort money from Tata Trucks (plying) on NH-2, shop keepers in and around Kangpokpi bazaar area along NH-2. On that, under the supervision of Smt. Amrita Sinha, IPS, Superintendent of Police, Kangpokpi district, a team of Kangpokpi Police Station and under the command of OC/KPI-PS led by the undersigned rushed to the area and searched for suspected person (s). In that near Changoubung village, two individuals were seen run away from the spot at the sight of our police team. Immediately, I along with my team chased after them but they tried to evade arrest however they were overpowered at the spot.

On questioning them at the spot, they identified themselves as: (1) Seitinthang Kilong (46) s/o Jangsat Kilong of Kangchup Makhom, Kangpokpi District and (2) Satgoulen Haokip (29) s/o Heneh Haokip of Kotlen village under New Keithelmanbi Police Station. Further, they disclosed that they are active cadres of United Kuki Liberation Army (UKLA). On spot searching, a book of transport receipt of UKLA, 3 nos. of mobile phone handset with Sim card of Airtel, Jio, BSNL, 1(one) Dio scooty B/R No. MNO1U-4664, black in colour, a sum of Rs. 7,100/ (seven thousand and hundred) only and one black air bag were recovered from their possession. Further, they disclosed that they have extorted money from three vehicles plying on NH-2 today itself under the command of one Davidson Haokip of Moreh.

They were arrested at the spot at about 7:30 pm and made a seizure memo by observing necessary formalities. The above arrested two persons along with seized articles have been handed over to you for further necessary legal action.
