



I have the honour to report that today , the 16th January, 2023 from 11:00AM to 12:10 PM a joint team of Kangpokpi District Police led by Addl.SP(Ops)Kangpokpi, SDO/SDM Champhai Sub-division, Kangpokpi Range Forest Officer , NAB-Imphal, 22 AR Kangpokpi Post, OC/KPI-PS and police personnel with the villagers of Harup Naga, Harup Khopi and Gorkha Jhil and Chawangking villages under the supervision of SP-KPI conducted destruction of illicit poppy plants at Harup Naga Hill Range under the T.Waichong Sub-Division in which illegal poppy plantation of approximately 10.50 acres which were planted by Mr T.Simon (44) S/o T.Bentangbou of Harup Naga village by breaking of land prohibited in the protected forest land were completely destroyed.

It, is therefore, requested to take up further necessary legal action as per provision of law.
