Subject : Report on recovery of weapons and ammunitions.

Sir,

With due respect, I have the honour to state that received an input from 17 FIT/3 Det. ARFIU regarding presence of Weapons cache in general area between Songjang vill and Thonglang Akuppa village along IT road. Based on the input, joint team comprising KPI District Police, 22 AR COB-Gelnal, B/20 CRPF led by Inspt. B. Lunthang Vaiphei under the supervision of SP Kangpokpi launched a search Operation in general area between Songjang village and Thonglang Akutpa village including adjoining jungles from 1030 hrs to 1400 hrs. A thorough search of the area led to recovered of 2(two) weapons and live ammunitions near Iron bridge located between Songjang Village and Thonglang Akutpa village along IT road at around 1400 hrs.

The recovered wpns and ammns are (a) 01 x 9mm Pistol (b) 01 x 9mm Pistol Mag. (c) 01 x 7.65 mm Pistol (d) 01 x 7.65mm Pistol Mag. (e) 10 x 9mm live rds (f) 02 x .32 mm live rds (g) 03 x 9 mm empty case (h) 02 x .32 mm empty case.

The above mentioned recovered weapons and ammunitions are being handed over to your custody for further necessary action from your end.
