Subject: Request to register an FIR against Mr. M Pramot Singh, Chief of the Meitei Leepun for openly spreading hate speech and discriminatory remarks against the 'Kuki' community in his interview with Mr. Karan Thapar on 06.06.2023 for 'The Wire'.

1. We, the undersigned do hereby request you to register an FIR against Mr. M. Pramot Singh, Chief of the Meitei Leepun in keeping with the orders of the Supreme Court in the case of Ashwini Kumar Upadhyay vs Union of India & Ors. (Hon'ble Justice K.M. Joseph and Hon'ble Justice B.V. Nagarathna) for openly spreading hate speech and discriminatory remarks against the 'Kuki' community in his interview with Mr. Karan Thapar on 06.06.2023 for 'The Wire'. The orders dated 21.10.2022, 31.01.2023, and 28.04.2023 are attached with this letter.
2. The Meitei Leepun is an organisation which claim to work to unite the people of Meitei community settling in different parts of the globe. It's a communal organisation with Meitei nationalist agenda to strengthen and safeguard the interest of only the Meitei community at the cost of other communities.
3. Mr. M. Pramot Singh is the current Chief of the organisation Meitei Leepun.
4. The organization have their own Volunteers and units everywhere, in all the districts of the hills and in the valleys of Manipur and conduct meetings at the meeting halls set up by them in various places.
5. That in the said interview, Mr. M. Pramot Singh has openly declared that if the Government, either in Delhi or in Manipur, does not intervene quickly, "there will be civil war" adding "the Kukis will not be able to defend themselves".
6. That Mr. M. Pramot Singh openly stated that if the government does not intervene, he spoke about a 15 kilometres area where, he claimed, the Kukis have set up roadblocks and encroachments, stating bluntly that they would be "wiped out" in that area.
7. Mr. M. Pramot Singh, Chief of the Meitei Leepun, who flew from Imphal to Delhi for interview also categorically proclaimed that the Kukis are "outsiders". He further said "they (Kuki) are not part of the family" adding they (Kuki) are "not indigenous to Manipur". He described the Kuki community as "tenants" in Manipur. More

importantly, he said that "the majority of Kukis are illegal" although he did not have any facts to back up this claim.

8. The complete interview episode with Mr. Karan Thapar under the title 'Meitei Pride' Group's Threat-Kukis Mainly Illegal, Modi Must Intervene Or There'll Be Civil War' is available at <https://youtu.be/VDJnPewUhmU>.
9. That Mr. M. Pramot Singh, Chief of the Meitei Leepun in his tweet/post dated 28.04.2023 had stated that "This is the right time..... let's annihilate our traditional rival on the hills and live peacefully". This post is a proof preplanned intention to attack the Kuki community.
10. That further Mr. M. Pramot Singh in his facebook had posted on 28.04.2023 that:
"Cut down the forest, dry up the rivers, finish them off, meanwhile let's build a homeland, ...this is our time. Then let's annihilate our traditional rival on the hills and live peacefully thereafter."
11. That it is also informed by reliable sources that Mr. M. Pramot Singh who is the current Chief of the Meitei Leepun is staying at the residence of Mr. Leishemba Sanajaoba, BJP Member of Parliament (Rajya Sabha) and is sheltering the said person which will be evident from the CCTV footages and the investigation which will be carried out.
12. The above extracted speeches indicate his hatred and inciting and promoting enmity against the Schedule Tribe community in general and Kuki community in particular.
13. Kindly therefore register the FIR immediately in accordance with the decision of the Supreme Court in Lalita Kumari's Case.
