The following properties of my houses were damages in the incident.

1. One house (Kutch house Approx. 5lakhs)
2. Paddy bags (10 no. of bags)
3. Cash (Rs 60 Thousand)
4. Gold (2 San)
5. Domestic animals like 4Hen, 5 Ducks, 3pigs, etc
6. Others house hold properties

The above damages properties worth above 8 Lakhs. I therefore, request to kindly taken up further legal action against the above unknown persons.
