- iv. Utensils - Rs 85,000/- approx.
- v. Cloths – Rs 65,000/- approx.
- vi. Electronics – Rs 30,000/- approx.
- vii. Gas set – Rs 15,000/- approx.
- viii. Piggery (7) – Rs 1,90,000/- Approx
- ix. Grocery – Rs 80,000/- approx.
- x. Water Tank – Rs 15,000/- approx.

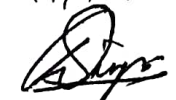
Total approximate value is about Rs. 16,50,000/- approximately.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.

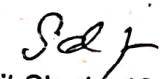

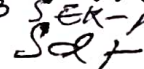
