- ii. Furniture - Rs 1,50,000/- Approx
- iii. Utensils - Rs 40,000/- approx.
- iv. Cloths - Rs 60,000/- approx.
- v. Electronics - Rs 55,000/- approx.
- vi. Gas cylinder (3 Three) - Rs 12,000/- approx.
- vii. Poultry (35) - Rs 17,500/- Approx
- viii. Jewelry - Rs 2,00,000/- approx.
- ix. Cash - Rs 90,000/-
- x. Water Tank - Rs 15,000/- approx.

Total approximate value is about Rs. 10,39,500/- approximately.
