Some unknown persons holding arms with deadly weapons numbering about 1000 suspected to be Kuki community from different villages were entered at Ekou Bazar village Imphal East District, Manipur and started damaging properties and burning houses.

The following properties of my houses were damages in the incident.

1. One house (Semi Pucca house Approx. 11 lakhs)
2. Paddy bags (80 no. of bags)
3. Cash (Rs 3 Lakhs)
4. Gold (3 San Approx. 15 thousand)
5. Domestic animals like 10 Hen, 20 Ducks, 7 pigs, etc
6. Others house hold properties
7. Rice Mill (Approx. 2.5 lakhs)

The above damages properties worth above 25 Lakhs. I therefore, request to kindly taken up further legal action against the above unknown persons.
