The following properties of my houses were damages in the incident.

1. One house (kutchra house Approx. 8 lakhs)
2. Paddy bags (30 no. of bags)
3. Cash (Rs 70 thousand)
4. Gold (5 San Approx. 75 thousand)
5. Domestic animals like 20 Hen, 15 Ducks, 7 pigs, etc
6. Others house hold properties

The above damages properties worth above 16 Lakhs. I therefore, request to kindly taken up further legal action against the above unknown persons.
