I have the honour to report that, on 08/05/2023 at around 10:30 pm, the large number of kukis rioters with knives, sticks, iron rods, weapons sharp objects etc, broke into my house and completely burn down my house located at Kangpokpi Ward No. 12 opposite to DC Office.

The properties that were burn down are as follows:

- x. House- Rs. 4,60,000/-
- xi. Electronic, Furniture, clothing, utensil, Jewelry, water pump, pipe, syntax, water tank 2 nos. and bicycle 2 nos. – Rs. 8,55,600/- approx
- xii. Aadhar card 7 nos., PAN card 5 nos., Bank passbook 3 nos., 1-ATM card, HSLC, 10+2 Certificate, BSc. 1st to 4th Semester and other domestic items (duck-15, 1-dog) – 36,250/- approx

Total approximate value is about Rs. 13,51,850/- approximately.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
